TOP HITS & POTENTIAL POLL QUESTIONS

- Santos claims that he graduated with an MBA from New York University and a
 Bachelor of Economics & Finance degree from Baruch College. However, the
 registrar offices at both institutions said there was no record of Santos earning any
 degree from either university.
- Santos was married to from 2012 to 2019. It is unclear what immigration status was at the time of the marriage.
- While married to social media posts indicate that Santos dated and lived with a man who was an illegal immigrant. The man later said he was fearful of being deported once Trump was elected. Santos began dating his current partner/fiancé while he was still married to
- Santos said his most controversial political stance is that he supports giving DACA
 recipients green cards. He acknowledged it is an unpopular position for
 Republicans but believes America has more to gain from the contributions of this
 subset of undocumented immigrants. Santos supports an "open door" for those
 who received temporary status from the Obama administration.
- Santos has made a career out of working for companies that have been accused of fraud and scamming customers.
- Santos' career began on Wall Street, working for firms that were directly responsible for the 2008 economic collapse.
- While a candidate for Congress in 2020, Santos was working for a company that the SEC later accused of operating a "Ponzi scheme" and defrauding investors.
- Santos' former boss was accused of misappropriating \$5 million to pay off more than \$1 million in credit card debt and using the illegal proceeds to buy a waterfront home and a Mercedes. As an employee, Santos had said the company was "well led."

- One victim of the company where Santos worked was an elderly woman living on Social Security, who says she was told that if Donald Trump were elected, the stocks and bonds she was invested in would plummet.
- Santos worked for a Turkish-based company with a litany of customer complaints and scam allegations. The complaints continued while Santos worked there.
- Santos says his professional experience is working in finance and helping wealth grow, but his personal financial disclosure filed with the Clerk of the House of Representatives shows no personal investments or assets.
- Between 2014 and 2017, at least three housing eviction lawsuits were filed against Santos and his family in Queens County, New York.
- Santos has had multiple civil judgments filed against him for owing thousands of dollars to creditors.
- Santos' driver's license is suspended in Florida, and he has at least five unpaid traffic violations in the state. It remains illegal for him to drive there.
- Santos campaigns on the message that candidates who do not live in their districts, do not share the same burdens or struggles as their constituents. But Santos was not registered to vote in New York's 3rd Congressional District until October 2020

 after he was running for office.
- Santos is running for office in New York, but he registered his new company in Florida in May 2021.
- Santos' business in Florida was registered to a Bahamian national who is the agent
 of at least nineteen other companies in Florida. The man, described as an
 international investor, was the CFO of Santos' previous employer which is now
 under SEC investigation.
- Santos says he is socially liberal and "to be very clear, I am no right winger."

- Santos said the people who acted like thugs and stormed the capitol should be prosecuted to the fullest extent of the law.
- Santos blames politicians for New York City becoming what he called a "third-world hellhole." However, he has taken thousands of dollars in campaign contributions from a man who was ranked as one of New York City's worst landlords. In 2020, the landlord had six buildings with an average of 678 violations.
- Santos says government should be removed from healthcare but on a 2020 candidate questionnaire, Santos said he did not support the repeal of Obamacare.
- Santos says we need to catch up with the rest of the world and phase out the use of plastics. He also called for the Presidential motorcade to be composed of electric cars.
- Santos supports federal regulation of greenhouse gas emissions, and says the government has a role to play on solutions for clean energy independence.
- Santos does not support increasing federal funding for the elderly on Social Security or Medicare.

METHODOLOGY

Alabama Securities Commission: Accessed reported Cease and Desist Order against Harbor City Capital, the CEO, and affiliates filed while Santos was an employee of the company. The State SEC accused the company of advertising unrealistic returns on investments that did not exist, along with other fraudulent investments. More information can be view in the Harbor City Capital section of this report.

BeenVerified: Checked an associated email address (Manual Mexis Inquiry) to verify if it was registered by Santos. Santos' name and previous address in New York were a match for the email account.

Brevard County Case search: Used the Brevard Electronic Court Application (BECA) to search by name for cases associated with Santos, his business, or known associates. His business agent (via Devolder Organization), is named in a 2015 Circuit Court Civil Case involving the Brevard County Tax Collector for unpaid property taxes in the amount of \$2,938.16, but there were no direct cases involving Santos.

Brevard County Supervisor of Elections: Sent a search request for George Anthony Devolder Santos to the election office clerk and was told he did not reside/register to vote in Brevard County but was advised to contact the office in Orange County, FL (which had already been rejected by the Orange County clerk). The Orange County Clerk requested the known voter ID number from Brevard County in order to conduct another search. A Nexis file suggests Santos was registered to vote as of 2/9/16 in the county and participated in the 11/8/16 election as his last vote. Awaiting a response from the clerk as of 11/29/21.

Campaign website: Accessed and reviewed present and past campaign website for Santos for any changes made, or inconsistencies in policy positions. Since 1/12/21, his website no longer contains an "Issues" section.

Clerk of the House: Accessed Santos' 2020 personal financial disclosure though filed under Devolder. As of 11/29/21, a new report had not been uploaded to the Clerk's system nor has an extension been requested.

Federal Election Commission: Review of campaign filings, donations, campaign expenditures and personal contributions.

Florida Board of Pharmacy: Conducted a search for the name of Santos' fiancé who is reportedly a pharmacist because the couple has reported addresses in Florida. There is no such licensed pharmacist or technician who exists in Florida by the name of

Florida Division of Corporations: A search was conducted for information on Santos' registered business.

Florida Department of Health: Searched the Florida Board of Pharmacy license data base for Santos' fiancé's name, which includes Consultant pharmacists, nonresident sterile compounding, nuclear pharmacist, pharmacist, pharmacist intern, pharmacy administrative account, pharmacy technician, and registered pharmacy technician licenses. No results for were returned.

Florida Department of Highway Safety & Motor Vehicles (DHSMV): Conducted a driver's license check for Santos based on the license number from an issued ticket. As of Nov 23, 2021, driver license number is currently suspended.

Internet Archive (Wayback Machine): Reviewed Santos' campaign website for any changes that were made between 2020 and 2022 on issue positions or his personal background. The first cache of the website is from 3/13/20 and the website has been saved 102 times between then and 5/7/21, though there are a total of 146 captures of the website's home page. Since 2020, the "About George Santos" section has remained the same. The "Issues" section first available on the website in 2020, is no longer on the present-day website. Between 1/8/21 and 1/12/21, Santos removed the "Issues" portion of his campaign website.

Lexis-Nexis: Searched for media articles involving Santos.


Local Radio & Media: Reviewed local news sources, radio and podcasts for interview involving Santos.

New York Board of Elections: A request was made for publicly available voter registration and election participation information for Santos. On 11/14/16, Santos first registered to vote in Queens County. On 7/23/19, the address on file changed from

New York Unified Court System: A search was conducted for business-related cases by the owner's name for Santos and Devolder, though no results were returned. Also searched the Division of Administrative Services Criminal History Record for "George Santos" and "George Devolder," though no results were found. A party search conducted by variations for Santos' name returned several potential cases but there was limited case information available. There are several cases associated with the name "George Santos" in Queens County but with no additional personal information. In order to confirm it is the same Santos, any available documents related to the cases have been requested from the Queens County Civil Court, regarding Queens County Civil Court Index Numbers: CV-030833-18/QU, CV-086924-08/QU; and the eviction-related cases: #2014Q065469, #2015Q081414. The known information is included in this report.

New York Supreme Court: A party search conducted by variations for Santos' name returned no cases specific to him.

Orange County Court Clerk: A party search conducted by variations for Santos' name returned cases involving Santos and traffic violations. This information is detailed in the report.

Orange County Supervisor of Elections: Requested previous voter registration information for Santos, with name and address variations. The response from the clerk was that no man by the name of George Anthony Devolder Santos was ever registered in the county. However, other records show (and the Brevard Supervisor suggested) a registration date of 2/9/16 as a Republican with the last vote date in this jurisdiction on 11/8/16. Another request was sent to the clerk, awaiting response to further inquiry.

PACER: A party search conducted by variations for Santos' name returned no cases specific to him. A party search for known parties for his previous employer's was also done and the information is included in this report.

Queens County Records Department: Requested Case #s 3408-2019 and 9637-2013 from the clerk but was told both are matrimonial cases which are not accessible to outside parties. Presumably, these cases represent a divorce filing (case #9637-2013 from 5/16/13; case #3408-2019 from 6/4/19) records.

Reclaim The Records: Accessed their files related to New York Marriage records obtained through a previous FOIL request and subsequent lawsuit. Santos was married 8/2/12. All known information is included in this report.

Securities and Exchange Commission: Devolder International Investment is not registered with the SEC, nor is the registered agent, D&D International Investment. A review of the ongoing case related to Harbor City Capital, Santos' previous place of employment, was conducted.

Social Media: Reviewed the available social media accounts for Devolder-Santos (Facebook, Instagram, YouTube, Twitter) as well as the accounts of people closely associated with him. More details are included in this report and can be expanded upon if desired. For example, in 2019, Santos' sister posted on Facebook (in Portuguese) that she yelled at a (perceived) immigrant mother with a child in a stroller, threatening that she was going to deport her, and that the woman should "go back to the hole she never should have come out of."

Editor's Note: The case is still ongoing as of November 2021. The most recent court action was on 10/21/21. Santos is not listed as a defendant. A related civil case was filed in July 2021, naming the same defendants, with a demand of \$400,000 in damages.

In January 2019, Harbor City Capital filed paperwork with the Securities and Exchange Commission (SEC) which is required within 15 days after the first sale of securities. The company reported a sale of \$1 million in debt securities, but no revenues. "The federal securities laws require the notice to be filed by companies that have sold securities without registration under the Securities Act of 1933 in an offering made under Rule 504 or 506 of Regulation D or Section 4(a)(5) of the Securities Act. A company must file this notice within 15 days after the first sale of securities in the offering. For this purpose, the date of first sale is the date on which the first investor is irrevocably contractually committed to invest." [Securities and Exchange Commission Form D, Accessed 11/11/21]

The SEC filed an emergency action in federal court and temporarily froze the firm's assets to halt the alleged ongoing marketing fraud. "The Securities and Exchange Commission (SEC) has obtained a temporary restraining order and asset freeze against Melbourne, Florida resident accusing him of running an ongoing Ponzi scheme through his company Harbor City Capital Corp., LLC and other entities. Although characterized as an internet marketing company, allegedly structured the company to raise money from investors who would profit from Harbor City Capital's operations placing ads on the internet. In reality, according to the SEC allegations, used investor money for his own use and benefit and was operating a Ponzi scheme. The SEC emergency action, filed April 20, 2021, in federal court in the Middle District of Florida, halted the alleged Ponzi scheme and marketing scam that the SEC said was ongoing." From at least May 2015 and continuing through the present, Harbor City Capital Corp. ("Harbor City") and its founder and Chief Executive Officer, have raised more than \$17.1 million through a series of unregistered fraudulent securities offerings in several entities formed and controlled by Harbor City and

42. Moreover, Defendants Harbor City, HC Ventures, the HC SPEs, HC Digital, and HCC Media, through Defendant were operating a Ponzi scheme. Since Defendants promised investors high rates of return but generated no significant revenues from its touted business model, needed new investor money to make interest payments to existing investors.

Since 2017, used at least \$6.5 million of investor funds to make monthly interest payments and other payouts to investors in a classic Ponzi scheme fashion. As noted previously, was the sole signatory on all of the entity Defendants' bank accounts.

Marketing videos and pop-up ads on social media were used by the company to "woo investors," guaranteeing returns on investment. "Maroney used marketing videos through his Harbor Capital website and YouTube, as well as Facebook pop-up ads, to woo investors, guaranteeing returns on investment and saying that proceeds from investors would be used to finance more and more online lead generation campaigns. In this, he touted his 'pipeline' of business clients within the '\$200 billion Internet advertising sector.' issued offerings to investors as promissory notes, fixed-rate funding agreements, or high yield, secured bonds while promising investors monthly returns ranging from 1 percent to 5 percent—and annual returns from 10 percent to 60 percent." [Silver Law Group, 5/5/21]

The CEO took more than \$17.1 million by offering fraudulent unregistered securities to finance the business of online "customer lead generation campaigns," in which online sales leads were created and sold to third party businesses.

"While using money from the securities offerings to maintain his Ponzi scheme, the complaint says, also misappropriated more than \$4.88 million to buy a waterfront home, a Mercedes and pay off more than \$1 million in credit card debt. also transferred \$617,000 into Celtic Enterprises LLC, another company he controls, and \$394,000 into a joint bank account with his wife, [Silver Law Group, 5/5/21]

Defendants Harbor City, HC Ventures, the HC SPEs, HC Digital, HCC Media, and orally and in offering materials, made material misrepresentations and omissions to investors and engaged in a scheme to defraud and a course of conduct designed to deceive investors. Specifically, despite statements made by Harbor City, HC Ventures, the HC SPEs, HC Digital, and HCC Media in the offering materials that investor funds would be used to finance Harbor City's customer lead generation campaigns, Defendants misappropriated approximately \$4.48 million in investor funds, which was diverted for Defendant personal use.

CIVIL LAWSUIT

were intentionally made to induce members of the public, including Plaintiff, to rely upon them in what was a concealed and illegal Ponzi scheme.

24. At all times relevant, Plaintiff reasonably and justifiably relied upon the Defendants' intentionally false and misleading statements of fact to his detriment by executing the subscription contract. See Exhibit 1.

At the same time, he claimed his other clients were all making huge returns on their investments. When I sued him, he did not even bother to respond to the Complaint. I was awarded a default judgment, and still he has ignored the lawsuit. I recently learned that the company bank account has \$239.000. So much for the multi-million dollar promises he made to his former investors, and continues to make to new investors. Upon further investigation, I learned that is in fact who was indicted in Las Vegas along with his father for mortgage fraud. Fortune continued to shill for at seminars even after he knew I was not receiving payments. me hundreds of thousands of dollars, including my original principal and two plus years of interest." Alternatively, he may have been using the money he owed me to pay off his other investors, a classic sign of a Ponzi scheme. In any case, I am continuing to pursue him legally. 



"On June 25th, 2020, the Alabama Securities Commission filed a Cease and Desist Order against John Paul Maroney and his companies Harbor City Capital Corp. and Harbor City Digital Ventures, Inc. Based out of Melbourne, FL, advertises unrealistic returns on investments that, in fact, do not exist. The Securities Exchange Commission has no records of any of companies or the bonds he offers; the Alabama Securities Commission does not have any records either.



• The CEO of Harbor City Capital, and his wife had previously filed for bankruptcy in 2004. They owed the Internal Revenue Service and Texas Workforce Commission a combined \$7,260, with a total of \$76,899 in outstanding debt, not including their home mortgage. A total of \$70,838 of their debt was discharged without full payment. In the filing, his spouse was reported as disabled and was receiving Social Security Disability payments. On February 3, 2020, Magistrate Judge Lehrburger issued a Report and Recommendation recommending that Defendant's motion for summary judgment by granted. Dkt. No. 70.

Objections to the Report and Recommendation were due on February 18, 2020. To date, the Court has received no objections.

The Court has reviewed the Report and Recommendation for clear error and finds none. So Brassasin v. Barber, No. 06 Civ. 5978 (CS) (GAY), 2009 WL 1542707, at *1 (S.D.N.Y. June 2, 2009) (explaining that a "district court may adopt those portions of a report and recommendation to which no objections have been made, as long as no clear error is apparent from the face of the record").

Accordingly, the Court accepts and adopts the thorough and well-reasoned Report and Recommendation in its entirety. Defendant's motion for summary judgment is granted.

The Clerk of Court is directed to enter judgment for Defendant and to close this case.

VOTER RECORD IN NEW YORK

Records indicate Santos first voted in New York during the November 2017 General Election. Santos has missed several elections since then, including the 2018 Primary and General election, where Democrat Rep. Suozzi was re-elected to his second term, after threatening violence against President Trump:

'This is where the Second Amendment comes in quite frankly, because you know, what if the President was to ignore the courts? What would you do? What would we do?' Suozzi continued. A member of the crowd asked what the Second Amendment was, to which Suozzi replied, 'The Second Amendment is the right to bear arms. That's why we have it.' The answer was met with chatter and some nervous laughter. National Republican Congressional Committee spokesman Chris Martin accused Suozzi of suggesting the Second Amendment could be used as a means of opposing Trump." [CNN, 3/19/18]

- "Not all of his thoughts align with the president's, though. Santos says that while he is 'looking into' the effects of capping the State and Local Tax (SALT) deduction at \$10,000 as part of a package Trump signed into law years ago, he was not in favor of it at first. 'I did get some evidence that I might be wrong, and it might have benefited a large portion of the district, but I really need to continue the research that we're doing,' Santos said."

- A bill sponsored by Rep. Thomas Suozzi, marked the latest effort by blue states to fight back against certain provisions in the Tax Cuts and Jobs Act. H.R. 5377 which would eliminate the \$10,000 limit on SALT deductions in 2020 and 2021, increase the SALT cap to \$20,000 for married taxpayers filing jointly in 2019, and increase the highest marginal tax income tax rate to 39.6%. "The measure, dubbed the 'Restoring Tax Fairness for States and Localities Act' or HR 5377, proposes increasing the so-called SALT cap to \$20,000 for married taxpayers who are filing jointly in 2019. It also calls for the elimination of the SALT cap in 2020 and 2021. The bill, sponsored by Rep. Thomas Suozzi, D-N.Y, along with Reps. Bill Pascrell, D-N.J., and Mike Thompson, D-Calif., marked the latest effort by blue states to fight back against certain provisions in the Tax Cuts and Jobs Act. The 2018 overhaul of the tax code placed the \$10,000 cap on SALT deductions... Suozzi's bill also calls for raising the highest marginal individual income tax

rate. The Tax Cuts and Jobs Act slashed individual income tax rates across the board, lowering the top rate for the highest earners to 37% from 39.6%. The proposed legislation would raise the rates back up to 39.6% for the highest earners and reduce the income threshold at which the top rate would apply." [CNBC, 12/20/19]

The SALT deduction typically impacts higher-income filers in states with higher taxes like New York. The GOP tax bill passed in 2017 changed that deduction, capping the amount of state and local tax deductions someone could claim on their tax returns at \$10,000. 




