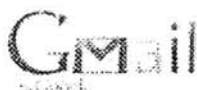

LIE #1: OBAMA SAYS HEALTHCARE COSTS ARE BECOMING MORE AFFORDABLE

THE CLAIM: Obama Said "Health Care Premiums Have Gone Up -- It Is True -- But They Have Gone Up Slower Than Any Time In The Last 50 Years." OBAMA: "The fact of the matter is that when Obamacare is fully implemented, we are going to be in a position to show that costs are going down. Over the last two years, health care premiums have gone up -- it is true -- but they have gone up slower than any time in the last 50 years. We are already seeing progress." THE FACTS: "For Now, There Is Little Evidence That The Affordable Care Act Has Made Healthcare Any More Affordable For The Vast Majority Of Americans." "President Obama reiterated a claim that his healthcare law will reduce costs, a promise he made when he started pushing for an overhaul as a candidate four years ago. Then, Obama said he would cut family health insurance premiums by \$2,500 by the end of his first term. Today, this stands as one of the president's biggest unfulfilled promises. In fact, the average employee share of an employer-provided health plan jumped from \$3,515 in 2009 to \$4,316 in 2012, an increase of more than 22%, according to a survey from the Kaiser Family Foundation and the Health Research & Educational Trust. The total cost of an average employer-provided family health plan - shared by the employer and the employee - reached \$15,745 in 2012. When the law is fully implemented in 2014, some low- and middle-income Americans will qualify for government subsidies to help them afford health insurance. And other provisions of the law could help slow the growth in healthcare costs over the long term. But for now, there is little evidence that the Affordable Care Act has made healthcare any more affordable for the vast majority of Americans." (Noam N. LIE #2: OBAMA SAYS GOV. ROMNEY'S PLAN IS A \$5 TRILLION TAX CUT

THE CLAIM: Obama Said "Gov. Romney's Central Economic Plan Calls For A \$5 Trillion Tax Cut." OBAMA: "Gov. Romney's central economic plan calls for a \$5 trillion tax cut - on top of the extension of the Bush tax cuts, that's another trillion dollars - and \$2 trillion in additional military spending that the military hasn't asked for. That's \$8 trillion. How we pay for that, reduce the deficit, and make the investments that we need to make, without dumping those costs onto

middle-class Americans, I think is one of the central questions of this campaign." (President Barack Obama, Presidential Debate, Denver, CO, 10/3/12)

THE FACTS: "Obama's Claim That Romney Wants To Cut Taxes By \$5 Trillion Doesn't Add Up." "Obama's claim that Romney wants to cut taxes by \$5 trillion doesn't add up. Presumably, Obama was talking about the effect of Romney's tax plan over 10 years, which is common in Washington. But Obama's math doesn't take into account Romney's entire plan." LIE #3: OBAMA SAYS HIS PLAN IS BALANCED IN THE MANNER OF SIMPSON-BOWLES
THE CLAIM: "Obama Often Claims That His Plan Has The 'Balanced Approach' Of The Simpson-Bowles Deficit Commission Proposal, But The Simpson-Bowles Plan Is Actually Quite Different." "Obama often claims that his plan has the 'balanced approach' of the Simpson-Bowles deficit commission proposal, but the Simpson-Bowles plan is actually quite different, calling for tough spending cuts and substantial tax reforms - not the faux proposals contained in the president's budget." "For instance, Simpson-Bowles envisioned \$4 trillion in debt reduction over nine years; the president's plan would spread the cuts over 10 years. A good chunk of the savings from deficit reduction piles up in that last year. When the two plans are compared apples to apples, Simpson-Bowles yields about \$6.6 trillion in deficit reduction - 50 percent more than Obama's plan." Independent Budget Analysts Were Not Impressed And Called The Maneuver 'A Major Budget Gimmick.'"** "Moreover, the administration is also counting \$848 billion in phantom savings from winding down the wars in Iraq and Afghanistan, even though the administration had long made clear those wars would end. In other words, by projecting war spending far in the future, the administration is able to claim credit for saving money it never intended to spend. (Imagine someone borrowing \$50,000 a year for college-and then declaring that they have an extra \$500,000 to spend over the next decade once they graduate.) Independent budget analysts were not impressed and called the maneuver 'a major budget gimmick.'" ROMNEY: "I have my own plan it is not as Simpson-Bowles. But in my view the President should have grabbed it. If you have some adjustments, make it, take it to Congress, fight for it." BARACK OBAMA: "That's what we've done. Made some adjustment to it. Putting it before Congress right now. \$4 trillion plan." (President Barack Obama, Presidential Debate, Denver, CO, 10/3/12)

THE FACTS: When Bowles Simpson Failed To Come To The Floor, "The White House Looked The Other Way." "In promising \$4 trillion, Obama is already banking more than \$2 billion from legislation enacted along with Republicans last year that cut agency operating budgets and capped them for 10 years. He also claims more than \$800 billion in war savings that would occur anyway. And he uses creative bookkeeping to hide spending on Medicare reimbursements to doctors." The President is counting money saved by letting the Bush tax cuts expire for people making more than \$250,000 a year. But he's also counting \$1 trillion in savings over ten years by drawing down the wars in Iraq and Afghanistan. The bipartisan non-profit Committee for Responsible Federal Budget has called that a gimmick because those wars were deficit-financed in the first place. And The President is also counting on savings agreed to last year when the White House and Congress agreed to raise the debt ceiling. Good morning! Thank you so much for being here today!

I especially want to thank XX and XX.

This is an exciting time for Washington State Republicans.

Good morning!

Thank you so much for joining me today!...

And thank you for your commitment to Eastern Washington and America.

This was an historic election - one of most important of our lifetime.

And now - with the start of a new Republican Majority in Congress - we have the chance to harness the will of the American people and deliver positive, fundamental change.

In only 100 days, we've already made progress by focusing on transparency, accountability, and returning to our Constitutional principles.

We've adopted institutional reforms, including...

- o Requiring a statement of constitutional authority for every bill that is introduced in Congress...
- o Requiring that NO bill be voted on without being available online for at least 3 calendar days, and...

These are the largest spending cuts in U.S. history... And they're just a start!

The New Majority is ready to move from cutting billions to cutting trillions!

A few days ago, we passed a budget that cuts spending by \$6 trillion over the next 10 years, and puts us on a path to balance the budget and pay off the debt – once and for all (!)

The new Republican Majority has many accomplishments from its first 100 days, but in my opinion, this is the greatest one.

Indeed, our budget is the best single opportunity to avoid a Greek-like debt crisis in the next few years.

Fiscal discipline is also essential.

Those who work in the private sector aren't fooled by the government's record spending and borrowing....They know that every dollar the government borrows will need to be paid back (with interest) – either in higher taxes or through inflation.

That's why we passed that historic budget: Because it will help our economy RIGHT. NOW (I)

Another thing that will help is repealing last year's radical health care law.

In my opinion, there will not be a true economic recovery until we create a climate where small business owners have the confidence to grow and create jobs again.

Fiscal discipline is essential to that climate.

Those who work in the private sector aren't fooled by the government's record spending and borrowing....They know that every dollar the government borrows will need to be paid back (with interest) – either through higher taxes or inflation.

We need to take bold action to reduce the deficit... and we need to do it now.

As a critical first step, last month, Congress passed - and the President signed into law - a budget for the rest of this fiscal year that cuts \$40 billion in spending.

These are the largest spending cuts in U.S. history... And they're just a start!

On April 15th, House Republicans passed a budget for Fiscal Year 2012 that will cut spending by \$6 trillion over the next 10 years.

While this budget has generated some controversy (ask Newt Gingrich!), I support the plan, and I encourage you to support it, as well.

However, we have to do even MORE.

I believe there is only one sure-fire way to balance the budget – and that's by passing a Balanced Budget Amendment to the Constitution (!)

The need for a Balanced Budget Amendment goes back 200 years.

In 1798, Thomas Jefferson wrote, "I wish it were possible to obtain a single amendment to our Constitution... taking from the Federal Government the power of borrowing."

In his Farewell Address, Ronald Reagan said there were 2 things he wished he had accomplished as President: A Balanced Budget Amendment and a Line Item Veto.

In 1997, the U.S. House did pass a Balanced Budget Amendment, but it fell one vote short in the Senate (one of the Senators who voted for it?: Joe Biden!)

In 2004 – during my first campaign for Congress—I called for a Balanced Budget Amendment; and today, I'm more convinced than ever that we need one.

The budget we passed for Fiscal Year 2012 doesn't include a SINGLE DIME for last year's health care law...

We are negotiating with the Senate as we speak.

In the meantime, we're staying busy.

Right now, we are using the courts to restore our health care rights.

As you know, last year's health care law required every American to purchase health insurance by 2014 or face annual penalties of roughly \$325.

This is a clear violation of the U.S. Constitution – specifically, the Commerce Clause and the Tenth Amendment.

And that's why 28 states are challenging the constitutionality of the mandate in court.

One of those states is Washington...And I applaud Attorney General McKenna for HIS leadership on this issue.

2 federal judges have already struck down the mandate.

And the most recent judge – Judge Vinson of Florida – declared that the entire bill is unconstitutional, as well.

I was proud to sign onto the amicus briefs in support of these challenges....

...And it's very likely they will continue all the way to the Supreme Court.

We will take the fight there – if that's what it takes.

After all, every American has the constitutional right to decide what health care is best for him and his family (!)

Now, I should mention that while I believe these are important steps to improving America's health care system, we can't just play defense.

We can't just repeal the bad parts of last year's health care law.

We need to REPLACE the law with common-sense, market-based solutions.

We should allow businesses to pool together to purchase insurance...permit insurance to be sold across state lines...and limit junk lawsuits.

We should also promote healthier lifestyles...deploy new health technologies...and expand access to care in rural areas.

After all, that's what the American people want...that's what they deserve (!)...
...And with your help, we WILL get it done (!)

Because of last year's health care law – and many other laws – since President Obama took office, America has fallen 3 spots in a non-partisan ranking of countries by their level of “economic freedom.”

We've gone from being the 6th-most free country in the world to the 9th-most free country – behind (among others), Canada!

Personally, I never thought I'd live to see the day when Canada was considered “freer” than America – and that's something we need to change!

To renew America, we need to unleash the power of “free minds and free markets”...and that's especially true when it comes to America's energy policy.

Since President Obama took office, the price of a gallon of gas has doubled...and many experts believe the price will hit will an all-time record this summer.

A lot of people ask, “How can we reduce energy prices?”

In my opinion, it's simple economics: “Supply and demand.”

“When demand goes up, you have to increase supply.”

Farmers understand it...Businessmen understand it...Even high school students understand it. Apparently, the only folks who don't understand it are politicians.

For years, politicians have artificially restricted the supply of energy.

To take one example: The President has imposed a year-long moratorium on energy production in the Gulf of Mexico....That has cost 12,000 jobs.

What this means, in practice, is that we are outsourcing America's energy industry.

This year, America will spend about \$500 billion on foreign oil.

We are essentially borrowing money from China to buy oil from Saudi Arabia.

Does that make sense?

We live in a country with tremendous natural resources.

We should start using resources to revitalize our economy, create jobs, and achieve energy independence.

Congress should pass a bold, comprehensive energy plan, and the basic principle of that plan should be "more of everything."

We need more oil.

We need more natural gas.

We need more nuclear energy.

We also need more renewable energy – such as solar, wind, hydro, and biomass.

Last week, Congress took a long stride forward by passing legislation to reverse the President's moratorium on Gulf energy production....But we need to do more!
