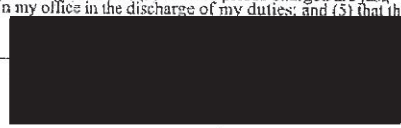

I. General Concept

1. Name. The organization established and bound by this set of by-laws shall be known as "Beauty World Guam Organization."
2. Essence. Beauty World Guam Organization is an exclusive organization composed of private civic-spirited residents of Guam bound together by friendship and cooperation with the principal aim of promoting the beauty of Guam – the land and its people, through specific projects of community interest.
3. Domicile. This organization shall be situated in Guam and shall direct and operate its projects from this domicile.

II. SCOPE / PURPOSE

1. Beauty Competitions. Beauty World Guam Organization will seek to arrange for the participation of Guam in international beauty competitions, realizing that such an activity engenders a healthy atmosphere for the island's tourist industry.
2. Travel. Members travelling to other countries will be equipped with brochures, literature and other informative tools about Guam to be disseminated to tourist-oriented agencies, organizations, establishments and individuals abroad. The members shall endeavor to study and learn as much as they can about the Island in order to achieve the capability to serve as tour guides and lecturers to visitors of Guam. Beauty World Guam Organization will assist in making travel arrangements for tourists and visitors who wish to come to Guam.
3. Assemblies. Beauty World Guam Organization will arrange or assist in arranging activities geared to tourism, such as trade fairs, international conferences, tourist-oriented civic projects, and others.
4. Editorial, Photo and Advertising Services. Beauty World Guam Organization will prepare or assist in the preparation and publication of written articles, brochures, press releases and other significant literature devoted to tourism and subjects related thereto.
5. Other Areas. Realizing that the tourist industry covers a broad scope of activities, Beauty World Guam, Organization will after due deliberation and decision of its members, support any worthwhile undertaking relevant to the pursuit of its objectives.

III. MEMBERSHIP

1. The initial membership of this organization shall consist of the charter members whose names and signatures are appended to this set of by-laws.
2. Future membership shall be by invitation subject to the approval of the Executive Committee.

IV. FINANCES / DUES

1. The membership fee is Ten Dollars (\$10.00), payable upon entrance to the organization.
2. Annual dues in the amount of Fifteen Dollars (\$15.00) per member shall be collected.
3. Special fees and contributions may be collected subject to the concurrence of the Executive Committee.
4. Any compensation for services rendered by this organization, or any income, donation, or resources realized by its projects shall not accrue to the benefit of any individual member. All financial resources of the organization shall be kept in a central fund to be donated to non-profit organizations/worthwhile projects. All funds and records thereof shall be open for review and audit of any member, authorized representative of the Government, bona-fide sponsor of the organization's projects, and all other patrons, whether individual or institutional.

V. Officers /Executive Committee

1. The management of the affairs of the association shall be vested in an Executive Committee, as defined in the organizations by-laws. No officer shall have any right, title, or interest in or to any property of this organization. The following officers shall be elected annually or as soon as any vacancy dictates the need to do so: President, Vice-President, Secretary, Treasurer and Public Relation. The duties of the Beauty World Guam Organization Executive Committee are as follows:

The President schedules and presides at all meetings; issues a call to all meetings, when needed, the president may delegate responsibility to any board member in a cooperative effort to complete the tasks of the organization. This power to delegate may be subject to review by the remaining board members. If there is a disagreement over any particular delegation, at least two-thirds of the officers (not including President) are needed to negate the particular delegation. President appoints the Committee Secretary and members to Standing Committees. Prepares and distributes agenda 1 – 2 days prior to the board meeting. The president executes the organization's activities and finances as approved by the Executive Board. He/she takes charge at meetings. Prepares and presents a report of all activities of the Organization for the annual meeting to Honorary President. Assigns interim Board assignment replacements in the event of illness or resignation.

The Vice President assists the President, shall act in the president's absence, and perform other duties as assigned. Assist in the development and maintenance of official website. Be a signature on the checking account as an alternate in the absence of either the President or the Treasurer.

The Secretary prepares and distributes notices of all meetings and ensures that the agenda and minutes of meetings are properly recorded, printed and distributed and have it available for all meetings. The Secretary also prepares correspondence as requested by the President and Committee members. Distributes printed materials as directed. Keeps

President of the Board informed at all times on all matters pertaining to the organization. Receives all contributions and sales income, records on ledger sheet and makes the bank deposit. Forwards a copy of the deposit slip and ledger sheet to the Treasurer. Records all expense (bills/invoices attached) and forwards to Treasurer for payment. Sends treasurer a list of all funds received. Writes all thank you notes and answers all correspondence of the organization with the approval of the Board President. Maintains accurate file of documents pertaining to correspondence. Assist in the maintenance of the organization's website. Sends reminders to members email and/or text messages one week in advance if time permits or 2-3 days before scheduled meetings. Maintains file of vital documents (Bylaws and Constitution, Minutes and Reports) and performs other duties at direction of the President of the Board.

The Treasurer is the custodian of all funds received by the Executive Committee and maintains accurate records of all financial transactions. Shall collect and document all payments, handle all cash and checks for deposits, record all financial expenditures, maintain the checking account and pay out funds on behalf of BEAUTY WORLD GUAM ORGANIZATION as approved by the membership. All checks will require 2 signatures at all times. All cash and checks received must be documented, reviewed and counted by more than one person and signed off by two (2) Executive Committee members. Must prepare and submit financial statement during all meetings. Have available all current and past bank statements for review. Perform such other duties as may pertain to the office of the Treasurer, including providing periodic financial reports to the organization. *Be a signature on the checking account.*

Public Relations/Affairs: Communicate with the public on behalf of Beauty World Guam World Organization. Spreads message to the public, often using the media as a conduit. Prepare press releases and contact people in the media who might print or broadcast material; arrange and conduct programs to keep contact between organization representatives and the public; represent Beauty World Guam Organization at community projects; keep the members informed about the activities of the Miss Guam World pageant and events.

Pageant Director: Oversees the Annual Miss Guam World Beauty Pageant event. This position is an Ex-Officio member of the Executive Committee.

Note: No officer, committee, committee member, or member of the organization shall receive any funds or incur any expense for BEAUTY WORLD GUAM ORGANIZATION not provided for in these BY-LAWS unless authorized by the President, with concurrence of the Executive Committee; nor shall the Treasurer or other authorized person make any payment except for expenditures which have been so approved.

The Miss Guam World Board functions as the leadership of the Beauty World Guam Organization, which is a non-profit organization. The board for the Miss Guam World is a

five to nine member panel appointed by the president. Board members are appointed to serve a two-year term. Because most members have a full-time job, family and other interests, it is acceptable to serve a one-year term as long as it is for one entire year (January – December). During the months of June – November meetings will be held often to accommodate the needs of the organization. The time commitment is approximately 1.5 hours per month but may extend to 2 hours. Monthly Meetings include the Honorary president (if her schedule permits), President and Pageant director or as requested by the President/Honorary President.

Additional time commitments may include pageant functions, approvals of budget, approvals of selection of vendors/companies for payments of checks in emergency situations, and additional meetings as deemed necessary.

Overview of specific duties of a board member:

- Participates in the development and oversight of fiscal, procedures, and programs for the Beauty World Guam Organization and make recommendations.
 - Submits items for agenda and approve minutes for board meetings.
 - Prepares a schedule of board meetings that meets the panel's needs.
 - Organize and manage the organization and its pageant according to bylaws.
 - Grow and develop the organization through fundraising and recruiting volunteers.
 - Share responsibilities.
 - Approve all contracts.
 - Seek at least 1 – 3 corporate sponsors within the community.
 - Are required to attend most board meetings, thus indicating your dedication to the organization and possibly pageant planning meetings.
 - Perform duties typical of directors in similar organizations.
2. Other official positions may be created by the concurrence of the Executive Committee and filled as the need arises.

VI. Meetings

1. Regular meetings shall be held at least once a month at a date and place to be decided upon by the members.
2. Special meetings may be called by the president, at the request of any member, provided at least two days notice is given to all members.

VII. Deliberation

1. For purposes of planning and decision-making affecting all activities of the organization, a regular or special meeting of all members must be called.
2. Any regular or special meeting shall be presided upon by a chairman to be appointed by the president; provided that the president shall see to it that, whenever possible, the chairmanship of meetings shall be rotated equally to all members.
3. At least the concurrence of a majority of members present in any meeting with a

quorum which quorum shall be a majority of the total membership shall be necessary for the adoption of any motion or resolution relating to finances, projects and relevant matters.

4. At least the concurrence of 50 + 1 majority of the total membership shall be necessary for the adoption of any motion or resolution relating to the invitation and acceptance of new members and changes or amendments to this set of by-laws.

**AMENDED CONSTITUTION
OF
Beauty World Guam Organization**

The undersigneds below, residents of Guam and of legal age, in order to form an association entity under statutes, adopts the following constitution.

I. NAME

The name of this organization shall be **Beauty World Guam Organization**.

II. OBJECTIVES/PURPOSE

The purposes for which this association is formed are:

- a) The specific and primary purpose is to conduct, annually, a local beauty pageant designed to select a delegate to represent Guam in the Miss World pageant, thereby stimulating international interest appreciation of Guam's culture, traditions, and customs, and thereby providing educational, career and travel opportunities to young women of Guam.
- b) All of the money raised goes to non-profit charities on Guam. To this end, the association shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

III. LOCATION OF PRINCIPLE PLACE OF BUSINESS/REGISTERED OFFICE

The Beauty World Guam Organization will be located at 124 Dago CT. Ligan Terrace, Dededo, Guam 96929.

IV. MEMBERSHIP/EXECUTIVE COMMITTEE

The organization shall have between 5-9 members. The management of the affairs of the association shall be vested in an Executive Committee, as defined in the association's by-laws. No individual member, officer or director shall have any right, title, or interest in or to any property of the association. The number of Directors constituting the first Executive Committee is between 5-9 members. Their names are:

VI. INUREMENT/POLITICAL CLAUSE

At all times shall the following operate as conditions restricting the operations and activities of the organization:

1. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or others private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.
2. No substantial part of the activities of the organization shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the organization shall not

participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

3. Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

VII. DURATION

The duration of the organization's existence shall be perpetual.

VIII. PERSONAL LIABILITY

No (member) officer, or Director of this organization shall be personally liable for the debts or obligations of this association of any nature whatsoever, nor shall any of the property of the (members) officers or Directors be subject to the payment of the debts or obligations of this association.

IX. DEALING WITH THE ORGANIZATION:

Conflict of interest. The Board shall adopt a conflict of interest Policy and provide for its implementation.

X. DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the local government, for a public purpose. Any such assets not disposed of shall be distributed, by the Superior Court of Guam in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

XI. OFFICERS

The Officers of this association are: The undersigned officers certify(ies) that they execute(s) these articles for the purposes herein stated.
