Thanks: please see below – and I'll apologize in advance that some of these questions are pretty invasive!

What we're getting at here is the exemption from the House of Representatives' gift rules for a charity event, which

would allow the Congresswoman to accept:

*"a waiver of all or part of a conference or other fee, the provision of local transportation [directly from the charity], or the provision of food, refreshments, entertainment, and instructional materials furnished to all attendees as an integral part of the event".*

These questions should get us started, and thanks in advance for your help!

1. **To absolutely be 100% sure, contributions to the gala benefit MMA, as a 501(c)(3) public charity with EIN 13-1624086 ([IRS record here](#))?**
2. **How do contributions for the event get to MMA?** Where are the admissions fees paid to, directly to MOMA? Or, to a third-party who pays the costs, then gives the profits to MMA (like a commercial coventure sort of setup)?
3. **Who has invited the Congresswoman to the event?** Under House Ethics rules, the Congresswoman can only accept an invitation to a charity event from the sponsor of that event – where the sponsor is the group “primarily responsible for organizing the event.” So, the Congresswoman could accept an invitation from MMA, but *not* from Vogue or Conde Nast.

What level of involvement does MMA – versus Vogue/Conde Nast – have in the planning and organizing of the event – the guest list, seating arrangements, and the like?

Since Advance Publications is a registered lobbyist, we’ll need to be extra careful on this one!

4. **Are there any other incidental benefits that we should know about, such as gift bags, souvenirs, or the like?**
5. **Are there events other than the gala that the Congresswoman has been invited to as a part of the above invitation?**

(Of note – this goes to the fact that the Congresswoman would not be able to accept entertainment collateral to the event, food or refreshments taken other than in a group setting with all or substantially all other attendees at the event (an afterparty, for example)).

David,

I wanted to flag one thing for you. The Charitable Event Exception to the Gift Rule has some fairly narrow wording. Under the exception, Members can accept free attendance for themselves and “the spouse or dependent child thereof.” See House Rule XXV, cl. 5(a)(4)(C). As a general matter, the Committee has taken a fairly narrow view of who counts as a “spouse or dependent child.” This is in contrast to the Widely Attended Event exception which permits acceptance of free attendance for the Member and “an accompanying individual.” See House Rule XXV, cl. 5(a)(4)(B).

Tom,

Thank you for this information – the Committee’s staff has always been extraordinarily helpful with answering questions that our clients have had, and we very much appreciate Tonia reaching out.

In this case, the situation was straightforward: the Congresswoman’s accepted complimentary attendance at this event, which was a fundraiser for the Metropolitan Museum of Art, a 501(c)(3) charity. The invitation was extended directly by the sponsor of the event, which was the Met. The Congresswoman was offered a guest ticket under that same criteria, and her longtime partner attended the event as well.

Apart from the ticket, the meals, and beverages at the event, the Congresswoman is paying personally for all other benefits including the rental value of her dress, handbag, and accessories, as well as the full value for the shoes worn.

The Congresswoman is also paying for the services related to her hair and makeup, transportation related to the event, and the pro-rated value of a hotel room that was shared with others for staging prior to the Met Gala.

If the Committee’s staff has additional questions regarding the Congresswoman’s compliance with the gift rules, we’d be happy to provide information or substantiation.

Tonia forwarded your email to me so I could clarify the scope of her outreach. Her initial email to your client's office was not because the Ethics Committee had questions for your client. To the contrary, Tonia is the Committee's Director of Advice and Education, and her email was a common, compliance-related outreach in which she was proactively checking if your client had any questions for us about the ethics rules and how they apply to events like the Met Gala. This is something we commonly do, particularly when there has been a high profile matter and we don't have a record of the office seeking the Committee's guidance on the issues involved.

In the course of providing that advice we would try to answer questions like:

1. How can a Member obtain a ticket, and if not paying for it, from whom can they accept a free ticket?
2. If the Member accepts a free ticket, can the Member accept more than one ticket, and if so, who can use the second ticket?
3. How can a Member obtain use a gown for such an event?
4. If something of value has been accepted that does not fit within a gift rule exception, what are the ways to rectify the situation?

Our initial goal was a brief, informal phone call on these issues, and as noted this is entirely voluntary and meant in the spirit of proactive customer service. If we can be of help with regard to these questions (or any others), please let us know. Often with these kinds of things phone calls are quicker and easier (and where outside counsel is involved, cheaper for the client). However, if you prefer to correspond in writing, that would be fine.
